

- 4) Financial bids of only those tenderers who have successfully completed atleast three similar works each costing not less than 40%, two works each costing not less than 60% or single work of 80% value of tender in last 5 financial years and current financial year of submission of bids shall be considered. Bidder shall have to submit proof of having successfully completed requisite number of works of specified amount by depositing requisite documents at stipulated time mentioned above.
