

- 2) If the opening date happens to be a holiday, then the same shall be opened on next working day at the same time.
- 3) The detailed tender notice and DNIT can be seen in the office of concerned S.E./ E.E or Executive Engineer (HQ) or downloaded from website <http://etenders.hry.nic.in> or www.hphc.org.in. The price bids of only those tenderers shall be opened who have deposited online requisite earnest money and cost of tender form. Technical bid document will also be submitted online. No other mode of payment shall be acceptable.
- 4) The contractors / societies enlisted with any Govt. Department / Board / Corporation are eligible to E-tender. However, the agencies enlisted with department except HPHC should get themselves enlisted with HPHC within three months after allotment of work
- 5) Financial bids of only those tenderers who have successfully completed atleast three similar works each costing not less than 40%, two works each costing not less than 60% or single work of 80% value of tender in last 5 financial years and current financial year of submission of bids shall be considered. Bidder shall have to submit proof of having successfully completed requisite number of works of specified amount by depositing requisite documents at stipulated time mentioned above.
Note for works at Sr. No. 12 :- Substantially completed works means those works which are atleast 90% completed as on the date of submission (i.e. gross value of work done upto the last date of submission is 90% of the original contract price) and continuing satisfactorily.
- 6) **Conditions for Sr. No. 2:-** The agencies who have installed the STP and executed the similar nature works i.e. three works each costing not less than 40%, two works each costing not less than 60% or single work of 80% value of tender in Comprehensive Maintenance Contract are eligible to participate for this tender. No enlistment is required for this work.
- 7) **Conditions for Sr. No. 3:-** The agency should be enlisted with MNRE / HAREDA or Original Equipment Manufacturers / Dealers / Distributor of SPV panel as per BOQ and no enlistment is required for this work.
