

The price bids of only those tenderers shall be opened who have deposited online requisite earnest money and cost of tender form. Technical bid document will also be submitted online. No other mode of payment shall be acceptable.
- 4) The applicant should have experience of having successfully completed similar works during last 5 financial years and current financial year as per following details.
 - i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
 - ii) Two similar completed works each costing not less than the amount equal to 60% of the estimated cost.
 - iii) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- 5) The additional conditions for the work:-
- a) Only Original Equipment Manufacturers will be eligible to participate in the bid process. The bidder should submit valid registration certificate, PAN No., GST number and various certifications appended in the body of DNIT.
 - b) No enlistment is required for this work.
