

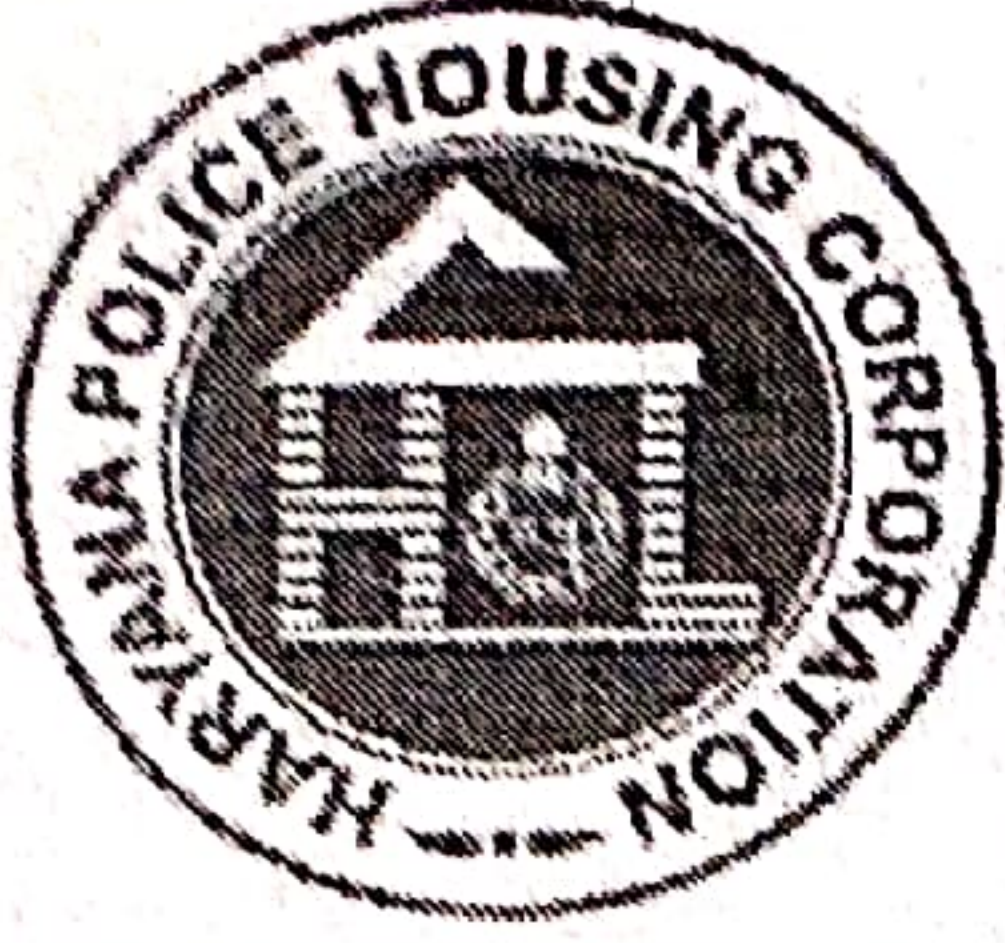

- 2) If the opening date happens to be a holiday, then the same shall be opened on next working day at the same time.
- 3) The detailed tender notice and DNIT can be seen in the office of concerned S.E./ E.E or Executive Engineer (HQ) or downloaded from website <http://etenders.hry.nic.in> or www.hphc.org.in. The price bids of only those tenderers shall be opened who have deposited online requisite earnest money and cost of tender form. Technical bid document will also be submitted online. No other mode of payment shall be acceptable.
- 4) The contractors / societies enlisted with any Govt. Department / Board / Corporation are eligible to E-tender. The enlisted copy of enlistment should also be submitted. However, the agencies enlisted with department except HPHC should got themselves enlisted with HPHC within three months after allotment of work
- 5) Financial bids of only those tenderers who have successfully completed atleast three similar works each costing not less than 40% or two works each costing not less than 50% or single work of 80% value of tender in last 7 financial years and current financial year of submission of bids shall be considered. Bidder shall have to submit proof of having successfully completed requisite number of works of specified amount by depositing requisite documents at stipulated time mentioned above. The amount of works shall be updated to price level of the last financial year at the rate of 8% per year compounded yearly
- 6) Only those Contractors who will create contractor I.D. on "Haryana Engineering Works Portal" are eligible to quote their bids.
